1 2. I also went on tour with Queensryche for 24 shows in 2010 as a performer, and
2 with Susan Tate's encouragement, the Rockenfields even listed their home for sale with me.


3 3. Since 2009 I have spent many holidays, birthdays, weddings and just fun
4 occasions with the Rockenfileds and Tates as well as Michael Wilton, Eddie Rockenfield, and
5 Parker Lundgren. My boyfriend has spent a lot of time with them as well, in fact he played
6 golf with Michael and Eddie in Florida.

7 4. We have also been at numerous concerts backstage with everyone even when I
8 was not in the show. At no time did I ever feel like there was any animosity between any of
9 the band members. We have never heard anything from any of the band member that they
10 didn't like Geoff or the Cabaret. I have NEVER seen Geoff be violent in any way — in fact, I
11 have never seen him be anything but a gentleman!

12 5. We went to see the Mayan ruins in Mexico during the Shiprocked cruise with
13 the Rockenfields and the Tates and Michael and his wife. Every event, every concert, every
14 time we've spent time together it has been like a big family.

15 6. These last couple months have nothing short of shocking — and the idea that
16 anyone was afraid of Geoff or that he is supposedly being violent, is the most shocking of all.
